6. OLD BUSINESS

I. DISCUSS AND TAKE POSSIBLE ACTION REGARDING APPROVING A RESOLUTION TO ACCEPT THE WIFA DESIGN LOAN. Sharon Hillman. The WIFA design loan was approved on April 28, 2021 and the district has received the loan documents. Included in the documents is a Board Resolution that needs to be signed by the District's attorney, Chairman, and Secretary of the Board of Directors. It has been signed by the attorney, but needs the other two signatures in order for it to be returned to WIFA. The current mini excavator is not capable of some of the jobs that the field crew needs to complete. This model Bobcat BC E-60 R2 is larger and has both 18" and 24" buckets. The funds are available in the Equipment Replacement Budget. The board reviewed the contract and asked if we could obtain the prices for the Extended Warranty and Preventive Service Maintenance Agreement. Sharon Hillman moved that the board approve the purchase of the Bobcat Mini Excavator at the state contract price and also get the prices for the other two items. George Gorkowski seconded the motion. The motion carried unanimously.
