#### Woodland Heights Waterline Replacement Project

Bids for the construction of the Project will be received at the Pine-Strawberry Water Improvement District Office located at **PO Box 134, 6306 Hardscrabble Mesa Rd., Pine, AZ 85544 until Thursday, December 15th, 2022 at 2:30 PM** local time. At that time, the Bids received will be **publicly** opened and read.

The Project includes the following Work:

**Woodland heights Waterline Replacement Project will include the installation of approximately 3 miles of water distribution system pipeline, new gate valves, new water services, and new water meters, to replace old 2-inch PVC pipe with glued joints, and miscellaneous small diameter water mains.**

Bids are requested for the following Contract: **Woodland Heights Waterline Replacement Project**

Project has an expected duration of **150** days and must be completed by **July 12th, 2023**.

4. Weekly certified payroll submittal is required under the Federal Davis-Bacon laws.
